Dauphin Island Sea Lab Foundation Annual Overview 2011-2012

Financial Information

The DISLF began FY 2011-2012 with total checking and savings balance of \$65,571.57 and combined Community Foundation balance of \$482,029 including fixed assets of 107.35 for total assets of **547**, **708.35**.

Ending FY 2011-2012 total checking and savings had a balance of \$168,140.08 and combined Community Foundation balance of \$468,322.12 for total assets of \$**636,462.20** an increase in total assets of 20%.

\$50,000 will be transferred to the endowment. The additions will be made quarterly with 75 % being added to the moderate fund and 25% to the short term.

The tax reporting calendar year has been shifted to reflect the budget calendar year of July-June. This should help simplify the yearly preparation of the form 990.

Fundraising

Grants:

- *Wells Fargo*-Wells Fargo funded a grant to underwrite an ROV field trip for schools with limited budgets in Mobile County. The Grant amount was \$4900. *The field trip will begin in Fall, 2012.*
- *BP* BP funded a grant request to underwrite the ROV field trips for all the schools in Mobile County (grade 9). Awarded \$20,000. *The Field trips will begin in January, 2013.*
- *Moorer Foundation*-Funded a grant request to underwrite the construction of a new classroom to replace the old Endeavor classroom. Awarded \$25,000 *Construction will begin in the Fall of 2012.*
- *Mobile Rotary Club*-Applied for a grant to replace the ROV kiosk in the Estuarium. Request was denied.
- *Junior League Assistance Fund* Requested sponsorship for a scholarship to the summer science class at the Sea Lab. Request was denied
- The Women of Dauphin Island donated \$500 to the DISLF for operating costs.

Friends:

At FY years end in 2010-2011 we had added 73 (94 total new and old) new friends for a total income of \$10,480. At FY end 2011-2012 we have 65 friends for a total of \$13,130. Even though we have fewer friends we have more members giving at an advanced level. Out of the 65 current "friends" 30 are renewals.

A committee has been appointed to oversee the Friends of the Sea Lab. Recommendations have been made to launch a massive mailing targeting those with vacation homes on the

island. A list has been compiled and this will happen in the Fall of 2012. Committee members are Erin Wheeler, Luella Hunt, Lisa Goodloe, Mary Ellingwood and Angela Payne.

Cocktails with the Critters:

Cocktails with the Critters was held at Tacky Jacks on the Causeway on May 3. This was our 4th year at this location and the 2nd under the ownership of Tacky Jack's Restaurant.

Our attendance totaled **426** up 57% from 2011.

Ticket Revenue -The revenue generated through 69 ticket sales at the gate, brought in \$3,450. The individual ticket sales of 144 and donations brought in \$7307. **Totaling \$10,857 in ticket sales an increase of 20% over last year.**

Sponsorships – There were 60 individual sponsors generating \$9,050 + 45% LY. and of 41 corporate sponsors bringing in \$30,250 + 22% LY. **Totaling \$39,300 in sponsors + 27% LY**

Silent Auction –This year's auction generated a gross revenue of \$19,925 less consignment costs of \$2,421 resulting in net sales of \$**17,504** from 81 items, giving us an increase of \$5,839 up 53% LY.

Cocktails with the Critters, continues to gain momentum not only in its popularity as a fun event to attend but also in the growing interest in the future development of our Sea Lab though the Foundation.
